The Parents Group was very clear in expressing a preference for smaller groupings of residents and neighborhood homes to be completed in a timely manner. HCRS Exec. Director committed this

agency to the same preference, while noting that on some matters the Department of Community Services will be making the final decision. It was also noted Long Term Staff Retires during this meeting that the Department's Housing Division will be involved in supporting this relocation.
